

## COVID-19 Release

### Coronavirus COVID-19 Release, Assumption of Risk, Waiver of Liability & Indemnity Agreement

The 2019 Coronavirus – COVID-19 (hereinafter “Coronavirus”) is a known and rapidly evolving pandemic that is affecting travel worldwide, with continued spread and impacts expected.

Participant is fully aware of the current global Coronavirus outbreak, the current travel restrictions, and inherent risks involved if choosing to travel.

Participant understands that it is his/her responsibility to check the latest travel information regarding this virus outbreak with the CDC. <https://wwwnc.cdc.gov/travel/notices>

Participant understands that it is his/her responsibility to have travel insurance to ensure they have coverage for all medical needs and trip cancellation but understands that concerns or fear of travel relating to the Coronavirus are not covered reasons for cancellation relating to the Coronavirus/ Covid-19 and will be denied. Participant holds Missions Ministries, its members, affiliates, and agents harmless (hereinafter referred to collectively as the “Agency” or “MM”) for his/her election to not purchase travel insurance or any denial of a claim by a travel insurer as it relates to Coronavirus or any other claim under the policy.

***Travel insurance generally only covers unforeseen events. Most insurers classified Coronavirus as a ‘known event’ late January 2020. Please note that most policies have a specific clause stating they do not cover epidemics and pandemics, especially when travel warnings are in place. Participant understands that he/she is bound by the terms of the insurance policy as it relates to the Coronavirus/Covid-19.***

Participant is aware of the travel warnings, travel restrictions and rules and understands the risks related to them. Participant knowingly accepts these risks and releases the Agency from any liability and holds the Agency harmless for any travel restrictions, death, illness, cancellations by suppliers, hotels, airlines, or any other travel provider, financial loss, quarantining rules or measures put in place at airports or destinations the participant is traveling through. Participant further agrees to hold MM harmless for any financial penalties or fees imposed by the by suppliers, hotels, airlines, or any other travel provider due to cancellations or postponements due to Coronavirus/COVID-19 and agrees not to institute a credit card dispute or “charge back” to MM for said penalties or fees.

Participant is aware that additional screening procedures and restrictions may take place at airports and in public areas. Participant is aware that these restrictions may include mandatory face coverings and/or temperature checks in airports, hotels, or other means of transport.

Participant is aware that immigration restrictions may be put in place before or during client’s travels that may impede client’s ability to enter or exit client’s destination as planned.

Participant is aware that it is his/her personal decision to travel and is doing so with full knowledge of current travel recommendations and travel restrictions with regards to the Coronavirus and takes full responsibility for his/her actions with regards to this. Participant further agrees to comply with MM staff, policies, and governmental procedures for both the United States and Mexico.

Participant understands and confirms that MM, after reasonable inquiry, has provided participant with the best available information regarding pandemic protection policies provided by travel suppliers, including but not limited to airlines, hotels, cruises lines, tour agencies, transfer agencies or any other provider involved in clients booking, but that said suppliers may not enforce or apply said policies. Additionally, participant understands and is aware that even if said travel suppliers make a good faith effort to enforce said pandemic policies and procedures, some travelers may refuse to cooperate with said policies. Participant further holds MM harmless for any illness, injury, harm, and damages arising out of or relating in any way to the same, that may arise.

In consideration of the opportunity afforded to me and with full knowledge and acceptance of the risks associated with travel, I hereby release, indemnify, hold harmless and covenant not to sue MM, its officers, employees, volunteers, agents, representatives, and any other person involved either directly or indirectly, from all claims, suits, expenses, attorney fees and demands of any nature (including negligence) caused by, deriving from, or associated with this trip. I make these covenants, release and waivers knowingly and voluntarily. It is further understood and agreed that this Coronavirus/COVID-19 Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement is to be binding on my heirs and assigns and I sign it of my own free will.

I hereby acknowledge that this Agreement is to be binding by my signature for all travelers listed under this booking.
